- (a) Finalists have to do 10 minutes briefing and Q&A for 10 minutes in the interview meeting.
- (b) 5 Individuals or groups will be selected and 2 backups.

VI Selection result

- Selected Artists or Group will be noticed by email from Cultural Affairs of Hsinchu city and the list will be also release on the website of the Bureau of Cultural Affairs of Hsinchu city on 2018/12/18 (Tuesday) at 16:00 pm.
- 2. Selected Artist or Group will have to sign a contract for the studio use within 5 days after receive the notice or lost the quality to join the program.

VII Privilege and obligation

- The studios are only for making artworks, artworks display and art courses provided by the selected artists.
- 2. The utility fee of the studio should be paid by the users (the selected artists).
- 3. The studio users have to pay management fee 600 NTD per month.
- **4.** The selected artists have to attend quarterly meeting, and annual exhibition/activities hold in Art Site of Railway Warehouse of Hsinchu city or Bureau of Cultural Affairs of Hsinchu City in the last quarter of 2019.
- 5. According to the activities of studios in art site, the management team will arrange art courses or exhibitions for the selected artists by quarter.
- 6. The studio should be used before 2019/04/01 or the selected artists will be deemed to give up the qualification to use the studio.
- 7. The proprietary rights of artworks created in the art site is belong to the artists, and management team and the Hsinchu City Cultural Affairs Bureau have right to arrange exhibition for these artworks in the program period.
- 8. As selected artist passes the annual review for the reaching rate of achievement for the annual project plan, feedback plan and the prescriptive open hour, the artist or the group will receive the certificate issued by the Cultural Affairs Bureau of Hsinchu city after this annual program is finished (finish date: 2019/12/31).
- 9. The management team of site has to respect the right of privacy of the artists.
- 10. The management team of site has to promote the exhibition and activities hold by selected artists in studios.
